Application deadline is October 1<sup>st</sup>, 2024. Applications received will be reviewed weekly leading up to the event. If not selected, you will be placed on a waiting list.

## **Cost**

\$100 per 8 foot table. \$200 for a 10X10 booth. Electrical is *not* an additional cost. There will be a \$16.00 fee for those who do not have a City License as we will provide one for you. Tables, chairs, and table skirting is available at no extra cost. All credit card payments are subject to a 3% convenience fee.

#### **Payment**

Payment will be required by November 1st, 2024.

Cheques should be made out to Provincial Exhibition of Manitoba and mailed/dropped off.

#### What is provided?

All Vendors will receive one (1) table and two (2) chairs per booth space. Skirting for your table is available.

#### **Electrical Usage**

Electrical is included in the table rental and only available to the vendors placed along the outside walls. Vendors must use CSA approved extensions or power cords. All cords must be unplugged at the end of day for 2-day events.

#### Set up/Take Down

Set up: Friday, November 22<sup>nd</sup> from 12pm-6pm and Saturday, November 23<sup>rd</sup> from 8:00-10:00am Take Down: Sunday, November 24<sup>th</sup> from 3pm-4pm

# **Important Building Information**

The Dome Building is a treasured historical site/building. We ask that you respect the site and the building while you are here. You will not be allowed to attach items to the wall, remove screws, move furniture/displays, or deface the property for your display. We want everyone to enjoy this space for years to come. Please let us know if you have any questions regarding your display.

# <u>Security</u>

The Dome Building will be locked and secured when closed. Vendors leaving their items at their booth are at their own risk. Do not to leave valuables unattended at your booth.

# **Smoking**

This is a non-smoking/vaping event. Smoking and vaping is strictly prohibited within the Display Building No. II per heritage regulations.

## **Permits**

Vendors are responsible for any permits required to sell their products. This includes, but is not limited to, permits relating to food and liquor items. City License will be provided by the Provincial Exhibition should Vendor not have one.
