# **Provincial Exhibition of Manitoba: CATTLE RULES**

- 1. Open to Juniors from the Ages **6–21 years as of January 1, 2025**. General Rules Apply to all Junior Livestock Exhibitors.
- 2. All Steers will be classified as grades & steer entries may be limited and be selected on a first come basis.
- 3. Any animals not in the barn by **9:00 am Wednesday April 2<sup>rd</sup>** will be disqualified from showing and be asked to leave.
- 4. All entries must be done online using Assist Expo. All payments are required before an entry is considered registered and complete.
- 5. Late entry fees will apply: an additional \$25/head plus GST for all breed classes, steer classes and showmanship classes. A late fee of an additional \$50/head plus GST for all Royal Lady Jackpot entries.
- 6. The total number of animals to be stalled must be checked on the online registration with Assist Expo. One stall/tie out is mandatory per head. **CCIA TAGS ARE MANDATORY**. and are necessary for accurate show book and placements
- 7. All entries are complete once payment is completed with online registration.
- 8. All entries are to be paid online through credit card application once you have completed your registration on Assist Expo. If cheque or cash payment is required, a processing fee of \$20.00 is required.
- 9. A culling committee will inspect all cattle. Animals culled will be removed from the premises immediately.
- 10. Steers with horns over 1" in length will be denied entry.
- 11. All winners of first and second prize must compete, if eligible, for the Championship in their respective classes or they shall forfeit their prize money.
- 12. Online entries must include the breed, name of the animal and sire must appear correctly on the entry form, or the exhibitor will not be eligible for special awards. Special awards are paid direct from the associations.
- 13. All exhibitors must be a member of the junior breed association of the animal they are going to show, not necessarily the owner.
- 14. Hay and shavings will be available for purchase on site. A bark mulch base will be provided. No straw will be allowed indoors for 2025.
- 15. Aisles and passageways are to be always kept clean and clear. No tack will be allowed in the center alleyway leading to the ring. Manure should be removed to the designated area daily (area TBA at the show). No Dogs allowed in the Barns at any time.

- 16. All animals must be halter broken. Failure to have animals' halter broke will result in a \$25 fine per animal and possible dismissal.
- 17. Tie out will be 7pm and tie in at 9am.daily. All animals to be in the barn before 9am daily.
- 18. No more than 2 animals to be lead at a time to tie-outs for your own safety, this means that no other animal/children are to accompany you during leading.
- 19. Tie-out space and Straw will be provided.

#### 20. If arriving Sunday March 30th TIE OUT will be \$25 for the week.

- 21. The barns will be closed at 9:00pm each night. No one will be allowed access to the barns after 9:00pm.
- 22. All entries accompanied by fees, must be made payable to the Provincial Exhibition of Manitoba by the entry closing date of March 19,2025.
- 23. Receipts will be issued by email once entries are complete and paid.
- 24. Any protests are to be submitted to the Show Office (addressed to the RMWF Cattle Show Committee) in writing along with a \$50 fee within two hours.
- 25. Exhibitors are to specify who they would like to be stabled with on entry form. <u>\*Enter</u> this in the notes area. Steers and heifers may be stabled together. **\*\*All sale steers are** to be stabled in designated area by 4pm Wednesday, April 2<sup>nd,</sup> 2025 \*\*
- 26. No animals shall be left in the barn after the release time of 7:00pm on Saturday, April 2<sup>nd</sup>.
- 27. PHOTOGRAPHS OF EXHIBITOR(S) AND/OR EXHIBITS: Each exhibitor shall agree that photographs taken of the exhibitor and/or exhibits by any photographer approved by the Royal Manitoba Winter Fair may be used for purposes of promotion by the RMWF or its official sponsors.
- 28. ABSOLUTLY NO ALCOHOL on the permitted or tolerated at this show.
- **29.** Fire Regulations: All fire hoses and exits must be kept clear of tack, etc. at all times. No exceptions. All electrical cords must be kept clear of shavings and other debris.

#### **30.** Health Requirements – For show only.

a. Canadian Livestock – No tests or health certificates are required.

#### DISEASED ANIMALS

In the interest of maintaining a high standard of animal health, all livestock are subject to inspection following delivery through the period of the show by veterinarians employed by the Provincial Exhibition of Manitoba. Animals found to have a contagious disease must be treated in the barn under the supervision of the official veterinarian. If conditions are found to be of serious nature, the owner may be required to remove the animal from the premises.

## **INSURANCE**

The exhibitor/participant, at his or her own cost, shall procure and maintain in full force and effect during the time of this Agreement, a Commercial General Liability (CGL) insurance policy or other insurance form acceptable to Provincial Exhibition of Manitoba management with a combined single limit of not less than *TWO MILLION DOLLARS (\$2,000,000.00 CAD)* for bodily injury or death and for property damage. The insurance policy must have a policy territory which includes Canada and be underwritten by an insurer acceptable to the Provincial Exhibition of Manitoba (generally AM Best rating of B+ or higher). The Provincial Exhibition of Manitoba must be added as an additional insured on the exhibitor's insurance policy:

Insurance coverage meeting the above requirements must be maintained during the period of *Sunday*, *March 30*, 2025, to Saturday April 5, 2025.

This insurance is designed to protect the attending public, other exhibitors/participants, the fair organizers as well as yourself against possible lawsuits arising from your participation at our event.

Exhibitors/Participants who have not provided proof of sufficient coverage will not be allowed to move-in, participate and/or set up until the insurance certificate has been provided to the Provincial Exhibition management.

If you already have Commercial General Liability Insurance in place and the Provincial Exhibition has been added as an additional insured, please provide the Provincial Exhibition with a certificate of insurance, this can be obtained from your insurance provider. Email to livestock@provincialex.com.

If you do not carry insurance normally, short-term insurance policies covering your liability exposure for the period of the event can be obtained by calling your insurance broker.

# Liability

The Provincial Exhibition of Manitoba will not be liable for any loss, damage, or injury to the Exhibitor/Participant, including its owner, rider, products, or employees. Exhibitors and Participants must maintain insurance on their exhibit, equipment, animals, and staff at their own expense.

The exhibitor/participant/owner/rider agrees to indemnify and hold harmless both the Provincial Exhibition of Manitoba and the Keystone Centre including their respective Directors, Members, Employees, Volunteers and/or the Show Committee against any and all claims of any persons whomsoever. The Provincial Exhibition assumes no liability for damages or losses resulting from or related to the failure of the Exhibitor to comply with the provisions of the agreement or the Manitoba Health regulations at the time. Under these circumstances the Provincial Exhibition is under no obligation to refund the Exhibitor's fees.

# **Brandon Fire Department Regulations**

The following Manitoba Fire Code Regulations shall be observed by all exhibitors at the Keystone Centre Complex, Brandon. Please note that there are revisions to the Brandon Fire Department Regulations.

#### Booth/Display Requirements

- Vertical panels at the back of the booth shall not exceed eight (8) feet in height (exceptions to the eight
   (8) foot regulation may be allowed by the Keystone Centre Complex and the Brandon Fire Department although pre-approval is
- All booths shall be constructed with non-combustible or limited combustible materials.
- Tents, that allow access to the public, must be fire resistant or treated with a flame retardant solution to meet with a flame test
  as per the Manitoba Fire Code.
- · Accumulation of combustible materials within a booth is prohibited.
- Exhibitors are responsible for maintaining their display within the space assigned.

#### Decorative Material

 All materials used for draping, decorations or dust covers must be fire resistant or treated with a flame retardant solution to meet with a flame test as per the Manitoba Fire Code

#### Hazardous Displays

 Hazardous displays of any nature shall not be permitted in any exhibition area. This includes but is not limited to hot flames, hot coals, L.P.G. lighters, charcoal grills, flammable liquids, toxic liquids or gases, hazardous chemicals, or any hazardous liquids, solids or gases of a similar nature.

#### Use of Propane

- No indoor use of propane of any size.
- Outdoor use is permitted.

#### Electrical Equipment

- All electrical equipment (portable panels etc.) shall be tied directly into the electrical panels. This shall be done by a qualified electrician.
- Surge protected power bars may be used for temporary power source (CSA Approved).
- If an extension cord must be used it is required to be plugged into a permanent power supply (CSA Approved. Must be unplugged when not being used and without supervision).
- All appliances shall comply with Manitoba Electrical Code or C.S.A.
- Ceiling tiles shall not be lifted to accommodate electrical drop cords.

#### Heat Producing Appliances

- All appliances shall be U.L.C. approved.
- All natural gas/propane connections shall be conducted, under permit, by a licensed contractor.
- Appliances that are heat producing shall be provided with an adequate barrier to protect the public from burn injuries.
- · When these appliances are operational they shall not be left unattended.
- All appliances must be approved for indoor use to be operated inside.

#### Fire Exits

- Exit doors shall be kept free of obstructions at all times. Chairs, tables and other display equipment must be clear of all aisles, corridors, stairwells and other exit areas.
- The entire width of the exit door/s shall be maintained free of obstructions.

#### Exit Signs

- Exit signs must be visible from any location in a room.
- Temporary exit signs may be required, to identify exit travel or exit door locations, if a display obstructs the existing exit signs.

#### Fire Hose Cabinets, Fire Alarm Pull Stations, Portable Fire Extinguishers

 Each of these fire safety supports must be visible and accessible at all times. Adjustments to space and equipment will be required. Nothing is to be stored in front of any fire safety devices at any time.

#### Non-Compliance Tickets

 Failure to comply with the above regulations may result in the issuing of a Non-Compliance Ticket with fines subject to the fee schedule as per Fire Prevention By-Law No. 6063/12/93.



# SHOW RING ETHICS

## IAFE (International Association of Fairs & Expositions) NATIONAL CODE OF SHOW RING ETHICS

Exhibitors of animals at livestock shows shall always deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to juniors as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE National Code of Show Ring Ethics", fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons, who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibitions in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age or any facts relating thereto is prohibited.

Owners, exhibitors, fitters, trainers, or responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.

Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.

Animals shall be presented to show events where they will enter the food chain free of violate drug residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or responsible person for show management to obtain any specimens of urine, saliva, blood or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state, and provincial statues, regulation, and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statues, regulations and rules affect the animals' performance or appearance at the event.

If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory to which it is sent is the ones taken from the animal in question, its integrity is preserved and all

procedures of said collection and preservation, transfer to the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise.

At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.

Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal is prohibited.

The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.

Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competition event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.

No owner, exhibitor, fitter, trainer, or responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.

The application of the code of ethics provides for absolute responsibility for an animals' condition by an owner, exhibitor, fitter, trainer, or participant whether he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.

The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including "Fairs and Expositions" and any special notice to members.

The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences and penalties provided for actions prohibited by the code. It is further consent that any action which contravenes these rules and is

also in violation of federal, state, or provincial statues, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

Royal Manitoba Winter Fair is committed to the belief that every animal shall be treated humanely. Activities or events that involve situations having a high probability of injury or illness to an animal are unacceptable to the goals and objections of Royal Manitoba Winter Fair.

#### CLASS - CS4 BOYS' AND GIRLS' CALF FEEDING COMPETITION

ENTRY FEE: \$25/head plus GST LATE FEE: \$25/head plus GST STALL FEE: \$87/head plus GST TIE OUT FEE: \$20/head plus GST ENVIROMENTAL FEE: \$10/head plus GST PRIZE MONEY: \$100 \$75 \$50 \$35 \$20 \$20

#### **RULES**

- 1. All General Rules and Regulations apply to this class.
- 1. Steers entered in this class will **BE SOLD** in a live sale Thursday April 3<sup>rd</sup> dependent on the number of entries received. They are not permitted to show in the single open steer classes. First and second place prize winners will compete for the Junior Champion of the show.

# 2. <u>Open to youth who have reached their 9<sup>th</sup> birthday but not their 20<sup>th</sup> birthday as of Jan. 1<sup>st</sup> of 2025.</u>

- 3. Competitors must have fed, cared for and fitted his or her animal for at least 3 months prior to the date of the exhibition. He/she must exhibit the animal in the show ring when judged and must take exclusive charge of the calf during the show.
- 4. Upon making entry, the name, address, and date of birth of competitor must be submitted with the entry of the animals' date of birth and breed.
- 5. Any exhibitor who is a member of a 4-H club is subject to the general rules governing 4-H club members. 4-H club members must feed an extra calf for this competition and will not be permitted to enter their club calf being fed for their local show as this entry will be sold in a live sale..
- 6. It is important and necessary for the Provincial Exhibition of Manitoba and the cattle industry of Manitoba that young people are encouraged to become interested in the showing and displaying beef cattle. Over the years, the boys' and girls' calf feeding competition has been a means of me encouraging this. Unfortunately, there is reason to believe that some of the rules, especially those pertaining to the period of ownership, are being circumvented. Should the executive and the cattle committee in conjunction and by majority vote thereof, believe that the period of ownership rule is being broken, the person in question may be excused or barred from showing or receiving prizes. All exhibitors and interested people are invited to help with the enforcement of this rule.
- 7. Blood samples to determine parentage may be drawn where deemed necessary.

#### 8. Steers to be born after January 1<sup>st</sup>, 2024.

**9.** All steers must be weighed on Wednesday, April 2<sup>nd</sup>, at 4:00 pm. Steers will be sorted by weight and shown in weight classes.

## SPECIALS FOR CLASS CS4

<u>MANITOBA ANGUS ASSOCIATION</u>: Offers \$100.00 to the Exhibitor of the Junior Grand Champion steer, providing they are a 50% Angus animal, declared at the time of making the entry.

<u>MANITOBA HEREFORD ASSOCIATION</u>: Offers \$80.00 for the five highest standing calves sired by a registered Hereford Bull which must be of 50% Hereford Parentage winning in the Boys' and Girls' Calf Feeding Competition to be divided as follows:

1st - \$20.00 2nd - \$18.00 3rd - \$16.00 4th -\$14.00 5th -\$12.00

These prizes will be awarded only to exhibitors whose calves stand in the top seven placing. In addition, special prizes of \$50.00 for first place and \$25.00 for second place will be awarded if they are 50% registered Hereford parentage and show definite Hereford color and markings.

**MANITOBA HEREFORD ASSOCIATION:** Offers \$200.00 to the exhibitor of the Junior Grand Champion Steer, provided the animal is 50% registered Hereford parentage. The Hereford Association reserves the right to conduct blood tests on entries' breed.

- 2. Entries to be made on the regular cattle entry form with name of calf, breed, and date of birth of animal and exhibitor.
- 3. All Steers will be weighed on Wednesday, April 2<sup>nd</sup>, 2025, at 4:00 p.m. This will be the official show weight, steers will be sorted by weight and shown in weight classes.
- 4. Exhibitors must be neatly and appropriately dressed when entering the ring.
