2025 SHOW FORMAT, RULES AND REGULATIONS

Fifteen Six Horse Hitches can be accepted to participate in the 2025 Royal Manitoba Winter Fair. Space and Entries permitting, **we can accept a limited number of two and four horse hitches.**

Entries are due February 17th, 2025. A payment including class entries, environmental fees and administration fees is required for entries to be considered valid. Administration fees are non-refundable. (3% credit card processing fee)

Selections will be made immediately after the **entry deadline of February 17th, 2025.** All unsuccessful entries will be notified and have cheques returned immediately after the draw.

FEES & ADMISSION

EXHIBITOR PASSES

8 free passes per 6 horse hitch / 6 passes per 4 horse hitch

Additional Armbands may be purchased for \$80.00 each including GST, for a 6 day pass.

WRISTBANDS ARE FOR HITCHING RING ACCESS ONLY ARE LIMITED TO OWNERS, DRIVERS, RIDERS, AND GROOMS.

Entry to the grounds may be made through all gates however, during the hours when public is invited to the grounds, a charge will be made at all gates. The Exhibitors entrance is located at 13th and Brandon Ave.

Please have armbands ready to show. **There will be no refunds given for Gate Admissions.**

Royal Manitoba Winter Fair Tack Room Competition

The Competition will be judged by a panel and awarded to exhibitors based on the following criteria:

1. Overall Appearance and Style (Maximum 40 points)
2. Cleanliness of Stable Area (Maximum 30 points)
3. Imaginative Use of either live or synthetic plant material (Maximum 30 points)

Displays will be disqualified if they extend more than a metre from the stall.

Sponsored by the Provincial Exhibition, winners in each of the Hunter/Jumper, Hackney, and Heavy Horse Shows will be awarded a ribbon or certificate and a \$100 prize.

Entries will display a sponsor banner when required

OPEN DIVISION

Cart Classes

Judging Specs: To show all around action at the walk, slow trot and working trot. To show responsiveness and alertness. Horses to stand quietly and back readily. To be judged on manners, performance, presence and quality. In Ladies to Drive and Junior to Drive, emphasis is on manners and the horse's suitability to and for being driven by a lady or junior. Working trot may be called at the discretion of the judge in Ladies to Drive and Junior to Drive.

Line Classes

ENTRY FEE: \$15.00 EACH ENTRY

JACKPOT: Prize money to be entry fees minus 20%, split 1st 40%, 2nd 30%, 3rd 15%, 4th 10%, 5th 5%.

10) **YOUTH SHOWMANSHIP** (Juniors Only)

- a) Judging Specs: Showing horse on the line with the following considerations: walk, trot, turn, backup, proper dress.

11) **YOUTH DECORATING** (Juniors Only)

- a) Youth Decorating Competition: Can work individually or in pairs with a handler. 30 minute time limit. Judged on mane decorating, tail tying and overall presentation.

12) **YOUTH JUDGING** (Juniors Only)

- a) Class will consist of participants judging and placing a class of heavy horses. Final placing will be done by the official judge. An entry must be made to be eligible for this class.



Two Horse Team Classes

Horses in team hitch classes must be of the same breed

Judging Specs:

Light Draft and Heavy Draft: Horses will be shown at the judges request, at a walk, slow trot, and working trot. Horses at all times are to show an ability to work as a unit with evenness of tugs, and to stand quietly and back readily. Hitches shall not be asked to fan except at the judge's discretion in case of a work-off. To be judged on performance, presence, quality, manners and matching.

Ladies Team, Youth Team: To be shown at a walk, slow trot, and at the discretion of the judge, working trot. Horses are to stand quietly and back readily, and are to be judged with an emphasis on the ability of the driver to control the team and perform the manoeuvres as well as the suitability of the horses to be driven by a lady or a youth driver, and the presence, quality, manners and matching of the horses. Fanning will not be required.

Tandem Team: Horses should at all times convey an image of alertness and style. The lead horse should keep the tugs from sagging, not be pulling the greater weight of the vehicle. Tandems will not be asked to back, except at the judge's discretion in case of a work-off. Fanning will not be required. Lead horse tugs must be attached to the wheel horse's tugs behind the belly band. At no time shall lead tugs be attached to the harness of the wheel horse. To be judged on performance, presence, quality, manners, and matching.

ENTRY FEE: \$15.00 EACH ENTRY

PRIZE MONEY: A draw will be made if necessary and teams will be put into splits with prize money in each class as follows: 1st \$150, 2nd \$130, 3rd \$110, 4th \$90, 5th \$70, Balance \$60

Juniors may not ride, drive, show on the line or handle stallions.

30) **UNICORN CLASS**

ENTRY FEE: \$30.00 EACH ENTRY

Judging Specs: To be shown at a walk, slow trot, and working trot. To stand quietly and back readily. At all times to show an ability to work as a unit with all three horses showing an evenness of tugs. Lead horse should show an alert and animated way of going and convey an image of style. To be judged on performance, presence, quality, manners and matching. The Unicorn will not be asked to fan except at the judge's discretion in case of a work-off.

PRIZE MONEY: A draw will be made and if necessary teams will be split with prize money in each class as follows: 1st \$300, 2nd \$250, 3rd \$200, 4th \$150, 5th \$100, 6th \$80, Balance \$60



300) **CHILDREN'S COSTUME CLASS**

ENTRY FEE: \$15.00

\$400.00 IN PRIZE MONEY

Open to a horse or pony ridden by a boy or girl 15 years of age and under as of January 1st of the current year.

To be shown mounted (riding) or to a cart. The class will be judged on originality, suitability, attractiveness, and manner. To be judged on presentation 60% and performance 40%.

Costumes can be fancy, traditional or original. All costumes must be safe. The committee reserves the right to dismiss or refuse entry to any entry if it's considered unsafe.

Prize Money: 1st - \$100 2nd - \$90 3rd - \$80 4th - \$60 5th - \$40 6th - \$30

FOUR HORSE TEAM DIVISION

DIVISION ENTRY FEE: \$100.00

Judging Specs: Teams are to be shown at a walk, slow trot, and working trot. At all times to show an ability to work as a unit with evenness of tugs, and to stand quietly and back readily. Hitches shall not be asked to fan except at the judge's discretion in case of a work-off, and are to be judged on performance, presence, quality, manners and matching.

40) FOUR HORSE TANDEM TEAM TO WAGON

- a) A draw will be made and if required teams will be split with prize money in each class.
- b) At a minimum, the **TOP TWO PLACINGS FROM EACH SPLIT** will advance to the Four Horse Team Championship. The remaining three teams will receive a consolation prize of \$200 each.
- c) PRIZE MONEY: 1st \$625, 2nd \$575, 3rd \$525, 4th \$475, 5th \$425

NOTE: At the conclusion of the class, the winning driver may be asked to complete a victory lap with the sponsor, and there may be a camera person in the box.



SIX HORSE TEAM DIVISION

DIVISION ENTRY FEE: \$150.00

Judging Specs: To be shown at a walk, slow trot and working trot and to stand quietly and back readily. Horses are at all times to show an ability to work as a unit with evenness of tugs. Hitches shall not be asked to fan except at the judge's discretion in case of a work-off. Teams will be judged on performance, presence, quality, manners, and matching.

The aggregate champion will be awarded from the overall points earned in Championship Classic A and B. Ties will be determined by the Four Horse Championship placings.

GENERAL RULES

- 1. LIABILITY:** All exhibits shall be under the control and direction of the RMWF but solely at the risk of the exhibitor. The RMWF will not be responsible for damage, injury, loss or theft of or to any exhibit, irrespective of the cause of such damage, injury, loss or theft, whether such is caused by negligence or not. Each exhibitor will be solely responsible for any loss, injury or damage done to, occasioned by or arising from any article/animal exhibited by him/her and shall indemnify the RMWF against all legal or other proceedings in regard thereto. **Completed entry forms must include a signed waiver form and proof of liability insurance, see below.** Damage to the Keystone Centre Facility, other than normal wear and tear, will be charged to the team stabled in that area. Please take care.
- 2.** Participants are required to carry in-force third-party liability insurance in the amount of no less than \$2,000,000 which defends against lawsuits and/or settlements for bodily injury or property damage arising out of the ownership, leasing or use of horses in the Royal Manitoba Winter Fair. This policy must have a policy territory which includes Canada and be written by a reputable insurer who is satisfactory to the Provincial Exhibition of Manitoba. Proof of such insurance is required to be submitted to the Provincial Exhibition of Manitoba with your entry forms.
- 3.** Prize money will be paid to the person whose name appears on the entry form as the owner unless otherwise specified on entry form. Juniors must have their parent's signature on the entry form and waiver forms must be filled out and signed. Juniors may not ride, drive, show on the line or handle stallions on the grounds.
- 4. CANCELLATION:** Royal Manitoba Winter Fair must receive **WRITTEN NOTICE** of cancellation via email or fax. (Any Refunds will be refunded after the show is complete.)
 - a. Cancellation before closing date: entries will be refunded in full.
 - b. Cancellation after closing date: Only after a Veterinarian certificate or Doctors certificate is presented to the show secretary will the class fees and exhibitor fees be refunded – stall fees and an office fee of \$30 will not be refunded.
 - c. Cancellation after the show begins: Upon presentation of a Veterinarian certificate or Doctors certificate to the show secretary, class fees for the divisions that have not been shown in, will be refunded minus a \$30 office fee. Stall fees and all other exhibitor fees will not be refunded.
- 5.** There must be at least three (3) entries per class shown, or the class **may** be cancelled. The Show Committee reserves the right to cancel classes. If a class is canceled it will be posted 24 hours before start time. Prize Money may be changed at the committees' discretion if there are not sufficient entries in a class.
- 6.** Behaviour of exhibitors and associates must be above reproach at all times. Failure to comply may result in ejection from the buildings, forfeiture of entry fees and suspension of exhibiting privileges. This includes **ALCOHOL**. Exhibitors are responsible to comply with the Manitoba Liquor and Gaming Act. Drinking is permitted in licensed areas only. Violators of this rule will be dealt with accordingly.
- 7. THINK OF THE HORSES! CITY OF BRANDON NO SMOKING BY-LAW IN EFFECT.**

- 8.** Dogs are allowed in the barns on a leash but will not be allowed in any area other of the complex. NO SCOOTERS, SKATEBOARDS, ROLLERBLADES, unauthorized Golf Carts, Gator style, and/or other similar vehicles in the Horse barns at any time. Those wishing to use such vehicles to travel to and from the camper area must park them at their own risk outside the barns.
- 9.** All livestock and other exhibits must remain in the barns or display area until release time as scheduled unless special permission is granted to remove said exhibit at an earlier time. All exhibitors failing to abide by this rule will automatically forfeit all or such portion of the prize money as the Executive Committee shall determine in its discretion, and offenders may be barred for one year.
- 10. PROTESTS:** All protests must be made out to the RMWF in writing and accompanied by a deposit of \$100.00 cash or certified cheque. Such protests must state plainly the cause of complaint or appeal and must be delivered to the Show Secretary within 48 (forty-eight) hours after the occasion for such protest. Complaints must be verifiable. Complaints will be reviewed by the Appeals committee. Note regarding judging: The judges' decision is final.
- 11. PHOTOGRAPHS OF EXHIBITOR(S) AND/OR EXHIBITS:** Each exhibitor shall agree that photographs taken of the exhibitor and/or exhibits by any photographer approved by the RMWF may be used for purposes of promotion by the RMWF or its official sponsors.
- 12.** All barns and stabling areas must be available to the public.
- 13. PLEASE NOTE:** To comply with fire regulations, there will be a 6 foot cross aisle, half way down the barn which must be kept clear at all times and includes electrical drops which are not to be in the cross aisle. This will be STRICTLY ENFORCED.
- 14. TACK ROOMS:** May we suggest....
All tack room curtains be made out of fire retardant material. No cooking in tack rooms.
For safety sake a ten (10) pound ABC type fire extinguisher should be kept in your tack room.
- 15. STABLING:** Stalls are allocated to ensure that the maximum number of exhibitors can be accommodated, and are assigned by the Horse Show Committee. All requests for additional tack stalls, box stalls, etc. will be considered, however there is no guarantee that additional stalls will be available.

DRAFT HORSE RULES

- 1) All animals in competition must be entered in the name of the bona fide owner, or their authorized agents, except for four and six horse teams. Affidavits of ownership may be requested. A Two Horse Team must be owned by the same owner.
- 2) Splits will be determined by the Show Committee. Decisions on splits will be final. Draws will be made for the championship classes order.
- 3) SUBSTITUTION of horses will be allowed in multiple hitch classes, when necessary, with written permission from the Horse Show Committee. The Show Secretary is to be notified of any substitutions.
- 4) Exhibitors will be limited to one entry per stable in each class of the show except Youth Showmanship, Youth Decorating, Youth Judging, and Youth Team. **NO cross entry** of drivers from Youth Team or Youth Cart to any other cart or team class. Juniors must be 17 years of age or under as of January 1st 2022. Regardless of the skill level of your youth driver, they must be accompanied by an adult during their class.
- 5) Heavy Horse Teams exhibited in the ring may be accompanied only by the driver and one attendant capable of lending assistance on the wagon. *Please wear appropriate dress attire in the show ring; this includes headers, drivers, and attendants.*
- 6) Barn will be available for decorating **Thursday, March 27th** after 12:00 noon and for move in **Friday, March 28th**. Warm up times will be posted at the Livestock office and throughout the facility. The Barn Superintendent will be available with a list of stall locations and allocations, these lists will also be posted in all barns. **Please check in ASAP upon arrival on the grounds at the show office and prior to unloading.** Stalls are to be kept decorated until the close of the show on Saturday night.
FREE first bedding will be supplied. Hay and Straw will be available to be purchased on grounds. There are no common areas available for hay or bedding storage. Please take this into account when ordering stalls.
- 7) Hitching: To ensure the safety of participants during regular classes, the hitching & un-hitching of teams, unicorns, 4's and 6's will take place in the upper hitching ring unless otherwise directed. For the 4 & 6 horse championships, exhibitors will be allowed to use the hallway from the south entrance of the Heavy Horse barn up to and including the upper hitching ring FOR HITCHING ONLY. Direction will be provided by the show committee for hitching.

BIOSECURITY PROTOCOLS AND REQUIREMENTS

The Provincial Exhibition of Manitoba along with the Royal Manitoba Winter Fair Executive in consultation with both veterinary and animal health authorities have developed protocols which have been deemed necessary in order to effectively manage any possible biosecurity concerns. We STRONGLY recommend that you consult with your veterinarian to design and implement the most appropriate vaccination protocol for your horse.

All horses entering the fair-grounds should not have been in contact with any sick horses within the last 14 days and are required to have their temperatures checked twice daily, with temperatures over 39.5° C or normal temperatures for your horse reported to the show veterinarian.

The Provincial Exhibition of Manitoba and Organizing Committee will monitor any potential biosecurity issues and will update procedures and requirements for all horses entering the grounds.

- **Restrict unnecessary movement of horses out of their aisle or barn. Don't take a horse to another barn to be tacked up, braided, clipped, bathed, etc.**
- **Do not lead horses down other barn aisles.**
- **Don't let horses make nose to nose contact with horses from other barns when in common areas such as wash racks or warm up rings.**
- **Do not touch or pet, or feed treats to horses from other barns unless necessary.**
- **Trainers- please make sure your braider knows about the Bio-Security regulations and takes care when moving from horse to horse.**
- **Do not let water hoses touch buckets when filling.**
- **Do not allow horses to drink from the hose.**
- **Do not share water or feed buckets.**
- **Have hand sanitizer readily available (in show office) and use between grooming/tacking up horses.**

Qualifying Vaccines for Mandatory EHV-1 and Equine Influenza immunizations:

EHV-1:

The AAEP(American Association of Equine Practitioners) has determined that the vaccines with the greatest ability to limit nasal shedding and viremia of the neuro virulent strain of EHV-1 include the vaccines licensed for control of abortion (Pneumabort-K® & Prodigy®), Calvenza® and the MLV vaccine Rhinomune®. These are the vaccines approved for use in horses attending the Royal Manitoba Winter Fair. The competitor must be able to show a signed vet certificate of an accepted vaccine including all boosters required with the horses registered name, or barn name and description can be used when registering. All EHV-1, EHV-1/4 vaccines labelled for use will be accepted and must be current within 6 months. Horses are required to have received these a minimum of 3 weeks prior to arrival of the RMWF.

Equine Infleunza:

ALL influenza vaccines approved for use are considered adequate for attendance to the RMWF. The competitor must show proof of purchase with any needed boosters and the vaccine must be current within 6 months of competition.

Brandon Fire Department Regulations

The following Manitoba Fire Code Regulations shall be observed by all exhibitors at the Keystone Centre Complex, Brandon. **Please note that there are revisions to the Brandon Fire Department Regulations.**



Booth/Display Requirements

- Vertical panels at the back of the booth shall not exceed **eight (8) feet** in height (exceptions to the eight (8) foot regulation may be allowed by the Keystone Centre Complex and the Brandon Fire Department although pre-approval is required).
- All booths shall be constructed with non-combustible or limited – combustible materials.
- Tents, that allow access to the public, must be fire resistant or treated with a flame retardant solution to meet with a flame test as per the Manitoba Fire Code.
- Accumulation of combustible materials within a booth is prohibited.
- **Exhibitors are responsible for maintaining their display within the space assigned.**

Decorative Material

- All materials used for draping, decorations or dust covers must be fire resistant or treated with a flame retardant solution to meet with a flame test as per the Manitoba Fire Code

Hazardous Displays

- Hazardous displays of any nature shall not be permitted in any exhibition area. This includes but is not limited to hot flames, hot coals, L.P.G. lighters, charcoal grills, flammable liquids, toxic liquids or gases, hazardous chemicals, or any hazardous liquids, solids or gases of a similar nature.

Use of Propane

- No indoor use of propane of any size.
- Outdoor use is permitted.

Electrical Equipment

- All electrical equipment (portable panels etc.) shall be tied directly into the electrical panels. This shall be done by a qualified electrician.
- Surge protected power bars may be used for temporary power source (CSA Approved).
- If an extension cord must be used it is required to be plugged into a permanent power supply (CSA Approved. Must be unplugged when not being used and without supervision).
- All appliances shall comply with Manitoba Electrical Code or C.S.A.
- Ceiling tiles shall not be lifted to accommodate electrical drop cords.

Heat Producing Appliances

- All appliances shall be U.L.C. approved.
- All natural gas/propane connections shall be conducted, under permit, by a licensed contractor.
- Appliances that are heat producing shall be provided with an adequate barrier to protect the public from burn injuries.
- When these appliances are operational they shall not be left unattended.
- **All appliances must be approved for indoor use to be operated inside.**

Fire Exits

- Exit doors shall be kept free of obstructions at all times. Chairs, tables and other display equipment must be clear of all aisles, corridors, stairwells and other exit areas.
- The entire width of the exit door/s shall be maintained free of obstructions.

Exit Signs

- Exit signs must be visible from any location in a room.
- Temporary exit signs may be required, to identify exit travel or exit door locations, if a display obstructs the existing exit signs.

Fire Hose Cabinets, Fire Alarm Pull Stations, Portable Fire Extinguishers

- Each of these fire safety supports must be visible and accessible at all times. Adjustments to space and equipment will be required. **Nothing is to be stored in front of any fire safety devices at any time.**

Non-Compliance Tickets

- Failure to comply with the above regulations may result in the issuing of a Non-Compliance Ticket with fines subject to the fee schedule as per Fire Prevention By-Law No. 6063/12/93.
