GENERAL EXHIBITOR RULES

These General Rules and Regulations apply to all Exhibitors, Employees, Performers, Tradesmen, and Concession Personnel, with no exception unless noted or approved by the Executive Committee, such decisions are final.

1. Any exhibitor who violates any of the General Rules or any of the rules printed in the Prize Book, and upon the decision of the Executive Committee, shall be liable to forfeiture of any prize money and awards they may have been awarded, and may be barred from further competition for a period decided by the Executive Committee.
2. Once the fair committee has set up a display no exhibit shall be removed, changed or sampled until the stated release time of exhibits.
3. All livestock and other exhibits must remain in the barns, or display area until release time as scheduled unless special permission is granted to remove said exhibit at an earlier time. All exhibitors failing to abide by this rule will automatically forfeit all or such portion of the prize money as the Executive Committee shall determine in its discretion, and offenders may be barred for one year.
4. The Exhibition reserves unconditionally the right to accept or reject any entry, and the right to inspect, examine or verify any entry.
5. It is the responsibility of the Exhibitor to make him/herself familiar with all rules of the Exhibition. The latest updated version can be found on our website.
6. Any protests are to be submitted to the Show Office (addressed to the Manitoba AG EX Cattle Show Committee) in writing along with a \$50 fee within two hours.

Manitoba Ag Ex Specific Rulings

- **Entries close October 9, 2026.** Entries received after the deadline may be subject for refusal.
- There will be no class Prize Money paid to purebred beef breeds at the 2026 show with the exception of the Angus show.
- **ALL CATTLE MUST BE CCIA TAGGED UPON ARRIVAL ON THE SHOW GROUNDS**
****There will be no exceptions to this rule.**
- Stalls and pens are to be cleaned into the aisles prior to **8:00 P.M.** and aisles and passage will be always kept clean and clear. No straw will be allowed for 2026. The exhibition will provide wood chip base to be spread before moving in time. Hay & shavings will be available for purchase on grounds but is suggested to pre-order with entry to assure availability. **Please bring your own wheelbarrow for handing of manure.**
- All Breed Champions **MUST** participate in the Supreme Breed Extravaganza on **Friday, October 31, 2026**. Failure to participate will result in forfeiture of Breed Prize Money and the RBC Beef Supreme certificate for Agribition.
- Sale animals are subject to 2.5% commission on sale amount and payable immediately following the sale to the Provincial Exhibition of Manitoba livestock office. (In Canadian Funds). Any animals passed are charged sales commission on the highest bid.
 - a. NOTE: See specific breed for rule on eligibility of sale animals.
- All exhibitors must be properly attired when showing in the ring.

- The Breeders Herd must be entered at the time of making initial online entry. It is not an automatic entry. Breeders' Herd is a Hays classification. ONLY purebred animals having previously shown in Hays Classification classes are eligible.
- Entries must coincide with the total number of animals to be stabled. Exhibitor will only be allotted stalls for number of stock brought to the show. Cow/calf pair class entry is considered one stall entry, but exhibitor is given 2 spaces for a unit.
- All entries must be owned and registered in the name of the Exhibitor. All registered animals whether owned by one person or by more than one person (individually or jointly) which are maintained on one farm or breeding unit are the production of one farm or breeding unit. Photocopies of registration papers must accompany exhibits.
- No refunds on entry fees unless accompanied by veterinary certificate. Certificates must be received by show time to be eligible for refund. NO refunds on stall fees. Exhibitors making entries and not exhibiting them shall forfeit all fees paid for entries.
- Substitution of entries within the same class by the same owner will be permitted without a veterinary certificate up to October 15th, 2026. After October 15, 2026 a veterinary certificate will be required. All substitutions must be accompanied by a photocopy of the pedigree of the substitution to prove ownership of that animal by the exhibitor as of October 1 of the current year. **A fee of \$40.00 will be applied on all substitutions. Fee for all cross substitutions will be \$75. Payable at the time of substitution. All substitutions must be made before noon on weigh day.**
- **There will be an additional \$25.00 office charge for every transaction after the original entry is made, in addition to late entry fees. This rule will be strictly enforced.**
- There will be a \$55.00 charge if cheques are returned for any reason.
- All animals must be halter broken. This rule will be strictly enforced by elimination. **All bulls over 12 months must have a nose lead/humbug whenever they are out of their stalls.** This rule is for the safety of all exhibitors and spectators alike and will be strictly enforced.
- Show harness is mandatory.
- No more than 2 animals to be lead at a time to tie-outs.
- **Steers must be ready for weighing Friday, October 30, 2026, from 4:00 - 5:00 PM** All other Livestock shall be in place by, Tuesday October 27, 2026, at 12:00 noon and not before 8:00 a.m. ALL animals will be released 4:00 p.m., Saturday, October 31, 2026.
- **EARLY RELEASE TIMES** must be requested at time of entry and may be granted on a case-by-case basis with Committee approval. Livestock must not leave grounds until release time without pre-approval. **Any livestock leaving before release time may be fined \$250.**
- All show cattle must be individually weighed.
- Unless otherwise stated, there are no restrictions on multiple exhibits in any classes exclusive of the Breeder's Herd & Get of Sire Class.
- Each breed **MUST** have a minimum of 24 animals and 3 exhibitors in order to have a show; however, there may be exceptions made by the show committee
- Breed supervisors (Barn Bosses) - The Manitoba Ag Ex Stabling Committee has complete authority of the stabling of livestock in the barns, allocation of tie-out spaces and control of trimming chutes and trimming in the barns. The Barn Superintendents are responsible to enforce all barn rules, including cleanliness of barns and aisles and to assist the exhibitors with problems in the barns. The Breed Supervisors are selected by the breed association to assist the exhibitors of their respective breeds. The

Breed Supervisors co-operate and work under the authority of the Barn Superintendents and Stabling Committee. Breed Supervisor (Barn Boss) duties include:

- Assist Breeders with Stabling upon arrival at MB Ag Ex.
- Read tattoos and check any substitutions.
- Assist with the weighing and processing of livestock.
- Co-operate with the Stabling Committee and Manitoba Ag Ex Management in keeping stall areas and aisles always clean and tidy. Ensure that the exhibitors have manure in the aisles prior to 8:00 P.M. each day and aisles and passageways are kept clean and clear.
- Enforce tie-out time of 6:00 p.m.; tie-in times of 8:00 A.M.; and release time of 4:00 p.m. Saturday, October 31, 2026.
- Assist the breeders with problems in their respective barn area.
- Attend Barn Boss meetings each morning at 9:00 a.m. with MB Ag Ex Management to provide information to ensure smooth operation of the show.
- Assist in the release of Sale animals.
- Assist the exhibitors and breed association with the Breed's respective show and sale.
- Maintain proper conduct and encourage co-operation among exhibitors.

- **Fire Regulations: All fire hoses and exits must be kept clear of tack, etc. at all times. No exceptions. All electrical cords must be kept clear of shavings and other debris.**

- Health requirements - for show only:
 - A. Canadian Livestock - No tests or health certificates are required.
 - B. American Livestock - All livestock from the US must meet all requirements for import into Canada. For the import of cattle, bison sheep or goats an import permit is required from the Canadian Food Inspection Agency (CFIA). Please contact your closest District Office of the CFIA or check the CFIA web page online for a permit application.
- Note: USA Exhibitors may wish to contact their USDA Veterinarians for further details however, a permit is still required for all ruminants imported for show or sale.**
- C. All Cattle are required to have a CCIA tag in their ear prior to leaving the farm of origin either for show or for sale. American cattle can have the tag applied at the first destination in Canada.
- Health requirements - For Sale Purposes
- D. Canadian Cattle – Sales Management may require that the cattle be eligible for export to the USA. At present all intact cattle (other than heifers going to a feedlot) from Manitoba require a TB test prior to export to the USA. Brucellosis tests are not required for export to the USA however some of the individual States may require this test. It is therefore up to Sales Management to instruct entrants if specific tests are required prior to the sale. Important: Potential exporters and importers should be aware that conditions for export and/or import may change by Manitoba Ag Ex date. Also, they should be aware that individual states may have individual requirements for health status, specific tests and for permits. It is the responsibility of the American purchaser to ensure that all requirements are met for import into the USA and into their particular state.
 - E. Diseased Animals - In the interest of maintaining a high standard of animal health, all livestock may be subject to inspection following delivery through the period of the Show by Veterinarians employed by the Provincial Exhibition. Animals found to have a contagious disease must be

treated in the barn under the supervision of the Official Veterinarian. If conditions are found to be serious enough, the owner of the infected animal shall be required to remove the animal from the premises.

- The exhibitor/participant, at his or her own cost, shall procure and maintain in full force and effect during the time of this Agreement, a Commercial General Liability (CGL) insurance policy or other insurance form acceptable to Provincial Exhibition of Manitoba management with a combined single limit of not less than ***TWO MILLION DOLLARS (\$2,000,000.00 CAD)*** for bodily injury or death and for property damage. The insurance policy must have a policy territory which includes Canada and be underwritten by an insurer acceptable to the Provincial Exhibition of Manitoba (generally AM Best rating of B+ or higher). The Provincial Exhibition of Manitoba must be added as an additional insured on the exhibitor's insurance policy:

Insurance coverage meeting the above requirements must be maintained during the period of October 26th, to October 31st, 2026. This insurance is designed to protect the attending public, other exhibitors/participants, the fair organizers as well as yourself against possible lawsuits arising from your participation at our event.

Exhibitors/Participants who have not provided proof of sufficient coverage will not be allowed to move-in, participate and/or set up their booth(s) until the insurance certificate has been provided to the Provincial Exhibition management.

If you already have Commercial General Liability Insurance in place and the Provincial Exhibition has been added as an additional insured, please provide the Provincial Exhibition with a certificate of insurance, this can be obtained from your insurance provider. Please email to <mailto:entries@provincialex.com>

If you do not carry insurance normally, short-term insurance policies covering your liability exposure for the period of the event can be obtained by contacting any insurance, Broker. Insurance certificates are to be sent to the Provincial Exhibition of Manitoba email entries@provincialex.com NO LATER than **October 9th, 2026.**
Entries are not considered confirmed until insurance information has been provided.

- **PHOTOGRAPHS OF EXHIBITOR(S) AND/OR EXHIBITS:** Each exhibitor shall agree that photographs taken of the exhibitor and/or exhibits by any photographer approved by the MB Ag Ex may be used for purposes of promotion by the MB Ag Ex or its official sponsors.

LIABILITY

The Provincial Exhibition of Manitoba will not be liable for any loss, damage, or injury to the Exhibitor/Participant, including its owner, rider, products, or employees. Exhibitors and Participants must maintain insurance on their exhibit, equipment, animals, and staff at their own expense.

The exhibitor/participant/owner/rider agrees to indemnify and hold harmless both the Provincial Exhibition of Manitoba and the Keystone Centre including their respective Directors, Members, Employees, Volunteers and/or the Show Committee against any and all claims of any persons whomsoever. The Provincial Exhibition assumes no liability for damages or losses resulting from or related to the failure of the Exhibitor to comply with the provisions of the agreement. Under these circumstances the Provincial Exhibition is under no obligation to refund the Exhibitor's fees.

BRANDON FIRE DEPARTMENT REGULATIONS



The following Manitoba Fire Code Regulations shall be observed by all exhibitors at the Keystone Centre Complex, Brandon. **Please note that there are revisions to the Brandon Fire Department Regulations.**

Booth/Display Requirements

- Vertical panels at the back of the booth shall not exceed **eight (8) feet** in height (exceptions to the eight (8) foot regulation may be allowed by the Keystone Centre Complex and the Brandon Fire Department although pre-approval is required).
- All booths shall be constructed with non-combustible or limited – combustible materials.
- Tents, that allow access to the public, must be fire resistant or treated with a flame-retardant solution to meet with a flame test as per the Manitoba Fire Code.
- Accumulation of combustible materials within a booth is prohibited.
- **Exhibitors are responsible for maintaining their display within the space assigned.**

Decorative Material

- All materials used for draping, decorations or dust covers must be fire resistant or treated with a flame-retardant solution to meet with a flame test as per the Manitoba Fire Code

Hazardous Displays

- Hazardous displays of any nature shall not be permitted in any exhibition area. This includes but is not limited to hot flames, hot coals, L.P.G. lighters, charcoal grills, flammable liquids, toxic liquids or gases, hazardous chemicals, or any hazardous liquids, solids or gases of a similar nature.

Use of Propane

- **No indoor use of propane of any size.**
- **Outdoor use is permitted.**

Electrical Equipment

- All electrical equipment (portable panels etc.) shall be tied directly into the electrical panels. This shall be done by a qualified electrician.
- **Surge protected power bars may be used for temporary power source (CSA Approved).**
- **If an extension cord must be used it is required to be plugged into a permanent power supply (CSA Approved. Must be unplugged when not being used and without supervision).**
- **No cords are to be run under or put underneath any woodchips.**
- All appliances shall comply with Manitoba Electrical Code or C.S.A.
- Ceiling tiles shall not be lifted to accommodate electrical drop cords.

Heat Producing Appliances

- All appliances shall be U.L.C. approved.
- All-natural gas/propane connections shall be conducted, under permit, by a licensed contractor.
- Appliances that are heat producing shall be provided with an adequate barrier to protect the public from burn injuries.
- When these appliances are operational, they shall not be left unattended.
- **All appliances must be approved for indoor use to be operated inside.**

Fire Exits

- Exit doors shall be always kept free of obstructions. Chairs, tables and other display equipment must be clear of all aisles, corridors, stairwells and other exit areas.
- The entire width of the exit door/s shall be maintained free of obstructions.

Exit Signs

- Exit signs must be visible from any location in a room.
- Temporary exit signs may be required, to identify exit travel or exit door locations, if a display obstructs the existing exit signs.

Fire Hose Cabinets, Fire Alarm Pull Stations, Portable Fire Extinguishers

- Each of these fire safety supports must be visible and accessible at all times. Adjustments to space and equipment will be required. **Nothing is to be stored in front of any fire safety devices at any time.**

Non-Compliance Tickets

Failure to comply with the above regulations may result in the issuing of a Non-Compliance Ticket with fines subject to the fee schedule as per Fire Prevention By-Law No. 6063/12/93.

SHOW RING ETHICS

IAFE (International Association of Fairs & Expositions)

NATIONAL CODE OF SHOW RING ETHICS

Exhibitors of animals at livestock shows shall always deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to juniors as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the “IAFE National Code of Show Ring Ethics”, fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons, who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibitions in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of violate drug residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state, and provincial statutes, regulation and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animals' performance or appearance at the event.

If the laboratory report on the analysis of saliva, urine, blood or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory to which it is sent is the ones taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise.

At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.

5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal is prohibited.
6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
7. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competition event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
9. The application of the code of ethics provides for absolute responsibility for an animals' condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including "Fairs and Expositions" and any special notice to members.
11. The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences and penalties provided for actions prohibited by the code. It is further consent that any action which contravenes these rules and is also in violation of federal, state or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

Manitoba Ag Ex is committed to the belief that every animal shall be treated humanely. Activities or events that involve situations having a high probability of injury or illness to an animal are unacceptable to the goals and objections of Manitoba Ag Ex.

MB Ag Ex Hereford Show abides by the MOE Show Rules as follows:

Depending on the show order, decided by the MOE show committee, heifer calves that win the honor of Grand or Reserve Grand heifer calf champion may not be shown as a pair; or heifer calves on a Grand or Reserve Grand champion cow may not be shown individually in the heifer calf class. A bull calf can be shown both ways.
